Sarah is currently an Advisor for Undergraduate and Masters Students in Social Work at UW Madison. In addition to mental health, she is familiar with other services in the Madison area and other career areas in this field. These include: policy advocacy, hospice/aging, homelessness, juveniles/youth, addictions, corrections, child & family welfare, School Social Work, Medical Social Work, developmental disabilities, etc. Social Work is an incredibly versatile profession—there are many areas to practice in and you can

Julia Sherman (Coordinator, Wisconsin Alcohol Policy Project, University of Wisconsin Law School) has spent her career working on public policy. Sherman served as Deputy Director of the Senate Democratic Caucus and later as the Director of the Assembly Democratic Caucus under Speaker Tom Loftus and then Speaker Walter Kunicki. Since 2010, the Wisconsin Alcohol Policy Project has worked to fill the gap in the resources and guidance available to Wisconsin's municipalities on the policies that prevent or reduce alcohol misuse. The project provides training, tools and technical assistance to elected officials, community coalitions and local health departments to support local efforts to reduce alcohol misuse. Sherman is a graduate of Marquette University and served on the Middleton City Council.

John Sinclair (Conservation Warden Supervisor, WI Department of Natural Resources)
