Negotiate restitution agreements, place clients in jobs and community service situations. Collect payments. Attend court hearings, develop new job sites, and counsel clients. Supervise work teams. **Private transportation helpful. Valid, unrestricted driver's license required.**

**Catholic Charities: Youth Living Alternatives** - Interns work with youth between ages of 12 -22 with mental illness and developmental disabilities in state licensed foster homes. This position equips students to assist in providing daily living skills, treatment planning, and assisting with community integration of youth in a home-like environment. **Community Resource Navigator Program, Center for Patient Partnerships** - The mission of the University of Wisconsin's Center for Patient Partnerships is to engender effective partnerships among people seeking healthcare, people providing healthcare, and people making policies that guide the healthcare system. Through the Community

Resource Navigator Program, UW Madison undergraduate students work as Resource Navigators in two local medical clinics. In this role students partner with patients to identify health harming social and legal needs, assist patients in connecting to social and legal community resources, follow up with patients to be sure that the connection was made and evaluate the quality of the resources provided. Throughout this experience students will: 1) learn about the important links between social/legal needs and health, 2) interact directly with patients to help them meet their needs, 3) develop direct advocacy skills. In order to participate students must complete all UW Health Volunteer requirements prior to starting in the clinics. 6 intern positions available.

**Dane County CASA (Court Appointed Special Advocates)** provides advocacy and mentorship through community volunteers to young people who have experienced abuse and neglect and are under the authority of the Dane County Juvenile Courts. The mission of Dane County CASA is to be an independent voice for these children under legal protection. Each year, CASA infuses thousands of hours of volunteer work by its highly trained CASA volunteers into the juvenile court system, and into the lives of the children we serve. We do this by training, supporting, and supervising community based volunteers who advocate for these young people in the community and in the courts with their best interest in mind. Volunteers can serve on cases where the child is involved in Child Protective Services and/or Youth Justice cases. Brief Description of Intern Activities: Helping to coordinate volunteer efforts on a case (including communicating with CASA volunteers, birth/foster parents, and CPS social workers) shadowing case coordinators in court proceedings, visits with CASA kids, and team meetings; helping with ideas and content for monthly volunteer trainings; attending staff meetings and CASA staff meetings; planning visits and brainstorming visit materials/ideas; attending juvenile judges meetings with judges and legal parties; reflective supervision. A car is not required but we are based out of The Canopy Center: 2445 Darwin Rd. Ste. 15 Madison, WI 53704. Our office is accessible by bus routes off of the Capitol Square and Campus area (route 2 and route 4 to route 20). The student will take part in our Initial training – a 7 week training, 1 night per week, 3 hours. **Students must be 21 years old. **Dane County Community Restorative Courts** The CRC provides young adults who are 17-25 years old and who have committed misdemeanor law violations in South Madison an opportunity to appear before a group made up of community members (prior to being charged) to ensure accountability, determine alternative sanctions and to help repair the harm done to the victim of the crime. It will also seek to help the offender with issues related to employment, healthy relationships, basic needs, and other personal matters to prevent re-offending. The CRC receives referrals of young adults, age 17-25 in South Madison, from law enforcement, the District Attorney's office and the community. Interns assist in providing case management, intake, leading court sessions, contact with referred individuals, community members and those who have been victimized. <https://crc.countyofdane.com/description>

**Dane County District Attorney, Deferred Prosecution Program** Intern with the Deferred Prosecution unit will maintain their own caseload. They are responsible for case management of agreements, assisting clients with finding treatment services, work and volunteer activities. **Dane County Department of Human Services, Youth Justice** There are several sites/offices in Dane County. This position works closely with the Juvenile Court. The primary purpose is to review all police referrals to Juvenile Court and to share the DCHS perspective concerning prosecution and disposition of cases with the District Attorney. Interns assist in reviewing police referrals, compiling data, sitting in on charging conferences with the prosecutor and attending court.

**Dane County Juvenile Reception Center** Intern accepts police referrals and conducts intake interviews for the Juvenile Court. Assists in making custody and detention decisions based on relevant statutes. **Dane County Juvenile Shelter** Provides short-term residential care for teens awaiting disposition of their court cases. Students assist in supervising daily living and recreational activities, providing educational support, and in providing counseling and referral services. **Application required.** <https://www.countyofdane.com/juvenilecourt/>

**Dane County Sheriff's Office – Dane County Jail (Social Service departments – Huber, Re-entry & Family Connections)** Under supervision of the Dane County Jail Social Worker and Re-Entry Coordinator, assist in providing services to inmates in the Dane County Jail. Assist in fostering and coordinating work release privileges and programming for sentenced inmates to reduce recidivism and address criminogenic needs. Assist in assessing inmate re-entry needs and coordinate with community resources to provide re-entry plan and services that address identified needs. Assist in preparation and facilitation of Parenting Inside Out group and coordinate services for inmates who are parents. Intern will be asked to attend team meetings and committee meetings in the jail and also in the community. Transportation is helpful but not necessary for this position. This position may also require some clerical work for preparation and follow up purposes. The jail setting is fast paced, any candidates should be able to work in this type of environment. Interns will also need to complete the required background checks and jail access orientations.

**End Domestic Abuse WI** Interns work in the Legal Department of the organization helping with tasks including: reading and collecting facts from criminal and family law cases as part of a large-scale data collection project. Interns have also helped in updating a legal manual for state domestic violence advocates, attending trainings for advocates and other individuals working with victims of domestic violence and shadowing agency staff. <http://www.endabusewi.org/>

Desire to work with clients in a community mental health setting is a requirement. **Must have private vehicle. Students may not interview with CTA if they are also interviewing with Mendota. Placement wishes to consider students interested in community mental health.**

**MRI study with MRN at Mendota Juvenile Treatment Center (MJTC):** Interns will be working with Research Coordinators on the current MJTC study as well as individuals in the follow-up study while gaining experience in the juvenile and criminal justice system. They will gain experience in a variety of psychological and personality assessments such as the PCL, trauma, AODA, crime, and IQ. Interns will see how to utilize prison files, public record sites, and social media searches to locate and contact follow-up participants. They will also learn how to enter data into the MRN COINS database as well as tracking information on a variety of spreadsheets. No previous research experience is necessary, although experience with adolescents is preferred.

**National Council on Crime and Delinquency** NCCD works with states, counties, legislators, law enforcement, and public and private organizations to demonstrate, test, and evaluate innovative alternatives to ineffective and costly justice practices. Assist with requesting records, compiling and reviewing pre-sentence investigations, attend sentencing hearings, and conduct bail evaluations and home visits.

**UW Law School-Family Court Clinic-** The Family Court Clinic is a community-based clinical law program serving Dane County's low-income residents. Students work on both individual client cases and perform community outreach through regular clinic hours at the Dane County Courthouse. Through their work, law students regularly engage with consumers from all economic, cultural, and educational backgrounds. They help consumers with their family law matters through answering questions, explaining court procedures, and assisting with form completion. Our courthouse clinic hours vary during summer and the school year but each law student staffs a three-hour shift each week. As part of your internship responsibilities you will be expected to observe court hearings, observe and assist with the FCC Courthouse Clinic, and handle a shift with our intake line at the Law School to schedule appointments with consumers.

**UW-Law School's Immigrant Justice Clinic (IJC),** represents non-citizens in immigration detention, including asylum seekers and residents of Dane County facing deportation because of immigration infractions. Interns at IJC interview immigrants at the Dodge County Detention Center and help assess their eligibility for relief from removal. They gather corroboration for cases in litigation, research country conditions for asylum cases, staff IJC's telephone intake line, and assist with case management and IJC's digitization project for its files. **UW School of Human Ecology--Improving Outcomes for Incarcerated Parents and Their Children During Jail Visits**

The purpose of this multidisciplinary research study is to develop and examine the feasibility, acceptability, and preliminary efficacy of a multi-level intervention to improve family visits between children and incarcerated parents in Dane County Jail. The intervention will focus on fostering positive family interactions through coaching during jail and home visits, creating family friendly and child appropriate spaces for jail visits, and promoting other correctional systems and facility-level changes that support child-parent contact such as offering in-home visits via laptops. **UW School of Social Work—Pathways for Parents after Prison**

The purpose of this research study is to develop and test the feasibility of a preventive intervention that promotes positive child and family outcomes using a multimodal approach to support fathers in reentry from prison. The intervention, delivered in partnership with Madison-area Urban Ministry, will focus on increasing parenting skills and knowledge, as well as fostering maternal and extended family engagement to enhance co-parenting and father involvement, and strengthen family bonds. **WI Department of Corrections - Division of Community Corrections, (previously called Probation and Parole)** Probation and parole agents assess an offender's risk and needs for programming, supervise offenders daily in the community, and also provide investigative services to the courts, the Division of Adult Institutions, and the Parole Commission to aid in sentencing and community reentry planning. Interns work with an agent, supervising clients living in the community or in prison. Duties include interviewing clients, conducting home and jail visits, case planning, attending court, and referring clients to local programs. **Must have a valid unrestricted driver's license. **WI Department of Corrections - Division of Juvenile Corrections- Grow Academy** Interns work with youth in a nonsecure, residential facility. Tasks include youth supervision, taking youth into the community, attending court, and food preparation. Students work closely with youth alongside staff. Interns provide daily mentoring of at-risk youth, supervising youth both on and off grounds. **\*Oregon is 10 miles south of Madison. Requires private transportation. Depending on background and experience, interns would be directly involved in various research-related efforts including conducting literature reviews, collecting data, identifying and addressing data quality issues, analyzing trends and patterns, and creating charts, graphs, tables, maps, and/or written reports based on the data analyzed. Interns may work with staff to provide individual, group and family counseling and guidance, provide services to protect the public, perform liaison functions with human services agencies, local units of government, and law enforcement agencies. Students will learn to refer and develop community and other resources. This position may provide a variety of services for a targeted caseload or program including Corrective Sanctions, Juvenile Parole and Serious Juvenile Offender. The work at this level is highly responsible and requires significant professional judgment and include accountability for actions.
