### Register for Pre-Internship Canvas site

Students who attend orientation will be sent an invitation to self-enroll. This site will be used for students to research agencies, fill out required surveys, submit application materials, and provide interviews updates.

**Submit a copy of your resume and cover letters for your top four placement choices,** along with any required applications, to our "Upload Resume, Cover Letters, and Application Materials here!" Survey

Please save resume as "LastName, FirstName Resume" as pdf.

Please save cover letter as "LastName, FirstName AgencyName" as pdf.

Advisors will send student application materials out to agencies and then inform students when they can reach out agencies to request interviews.

### **February to May- Interview & Accept Placements**

- If you have reached out to an agency to schedule an interview and have not received a response after 10 business days, follow up with the agency and CC cjcp@ssc.wisc.edu.
- At your interview, ask when you can expect a response and when you need to respond to an offer.
- Complete Secured Placement Quiz on Canvas (you will need the name of your supervisor)
- Discuss start and end date with supervisor
- Complete Agency Agreements via Docusign
- Applying to 4 agencies from our list does not guarantee an interview or an internship. If you are not
  interviewing or receiving offers, you should apply to more agencies. We will frequently send new
  opportunities and you should also research other opportunities.

### **Mandatory Summer Seminars for LS 694**

- Seminar attendance is required and part of your course grade.
- Students interning in the Madison, WI area will be attending in-person seminars; students interning far from Madison will be assigned to distant (virtual) seminars. Given scheduling and time limitations, inperson seminar students will not be able to switch to virtual seminars to accommodate absences.
- In-person seminars will be **Wednesday**, **June 26th and Wednesday**, **July 24th.** Seminars are for the full day and held on-campus in Grainger Hall. More info will be sent via email as seminar dates get closer.
- Students in the distance seminars will participate in two shorter online seminars at times TBD near these dates.

Between May 13 and June 3<sup>rd</sup> – Students should begin internship & journaling (discussed at Orientation #2)

Students must intern at least 10 weeks between 20-32 hours per week.

August 9<sup>th</sup> – Internship should be completed by this date
